

COURSE OUTLINE – SUPERVISED PRACTICE EXPERIENCE (RN414)

COURSE DESCRIPTION

This course provides a supervised clinical practice experience in a variety of clinical contexts. With regulatory approval, the individual creates a learning plan for the required hours of practice, in a specific clinical context, to facilitate their demonstration of the Professional Standards, Standards of Practice and relevant Competencies in managing the RN patient care load. The SPE is supervised by one or more preceptors who contribute to mid-way and final evaluation with the Nursing Education Consultant from JCC Inc. On successful completion of the SPE, JCC completes the regulatory evaluation form and forwards it to the health authority's professional practice office, for verification and submission to the regulatory college.

Pre-requisites:	Graduation from an entry-level registered nursing program. Temporary Registration - BCCNM. Completion of SPECO. Purchase of Insurance Policy

Co-requisites: Assignments/Coursework as directed by the Nursing .

LEARNING OUTCOMES

By the completion date of this course, the participant will:

- Demonstrate the ability to provide safe, ethical, and competent nursing care in the specific context of practice.
- Provide nursing care that meets the Professional Standards, Code of Ethics and Entry Level Competencies for RNs in the province.
- Manage the nursing workload for an RN in the specific context of practice effectively, efficiently and competently.

Modes of Instruction and Learning

This nursing practice course is completed in a specific clinical practice area (as assigned by the health authority) with various modes of teaching and learning (theoretical and practical) offered to support the participant.

Assessment and Evaluation

Assessment is conducted in collaboration with the JCC Nursing Education Consultant, the Preceptor, and the Participant, using the assessment forms provided in the SPE Guide Booklet. The evaluation is also based on the learning plan developed at the beginning of the course and updated as the course progresses. The course timeline may be extended to address any outstanding competencies or professional standards not met.

Withdrawal & Refund Policy

In order to withdraw from continuing education at JCC Inc., all participants must provide written notice. The date upon which this written notice is received will be used to determine the amount of any potential refund based upon the following policy:

(a) If written notice of withdrawal is received by JCC Inc. or a participant is dismissed within 4 calendar days since the participant's registration date, then JCC Inc. may retain 30% of the tuition.
